2023 Meeting Minutes

Date: April 26, 2023

In an effort to ensure a positive member experience, PFCU actively and continually solicits feedback from membership. This allows us to identify any challenges and work toward improvements. Loan Report

In 2023 PFCU had challenges with loan growth and opportunities. PFCU ended 2023 with 1.68% of loan growth, which was down from the 5.9% growth of 2022. We realized growth in mortgages, business lending, and indirect lending, which is done in partnership with our preferred dealers. PFCU did not have growth in consumer lending in 2023. At the end of 2023 we had achieved net loan growth of over \$8 million dollars. Delinquency and charge-offs remained low during 2023. PFCU has launched a new Ca\$h4me instant loan option in 2023. This new technology offers an online instant loan for our qualifying membership. This new product has proven to be a convenient lending option for our membership. We continue to seek new opportunities to bring lending products and services to the membership.

Though the last two years brought loan growth, 2024 will prove to be more of a challenge. That said, PFCU continues to have a strong financial standing with a focus on growth and a culture of building relationships with our members and employees.


